2.	Brief details of the Approval/License obtained	The Company has its LPWAN connectivity network across the country since 2017. In January 2022, the Department of Telecommunications ('DoT') amended the Unified License to include a new authorization under the name of 'Chapter-XVI
3.	Impact / Relevance of such Approval/License	<p>Machine to Machine (M2M)' mandating entities who are acting as connectivity service providers providing underlying network for connectivity and related services to M2M Service Providers, to obtain M2M Service Authorization. This authorization covered players like the Company, intending to provide IoT services exclusively through LPWAN or equivalent technologies using unlicensed spectrum.</p> <p>In view of the DoT notification, the Company had applied for and has now obtained M2M Service Authorization for Category A i.e., pan-India service, under its existing Unified License. It may be noted that the Company's Unified License with authorization of ISP, NLD and ILD services is valid till January 24, 2034 and the validity of the additional M2M Services authorization will be co-terminus with the validity of the Unified License.</p>

Period for which such approval/license is/was valid	While this service authorisation has a validity of 20 years, it is an additional service authorisation under the Company's existing Unified License which has been in effect from January 25, 2014 and shall be co-terminus with the validity of the existing Unified License.
